## **Startling Statistics**

- Sixty-three percent of Americans taking prescription drugs strayed from their physician's
  treatment plan and three in five were taking medications that weren't prescribed, according
  to a Stanford Medicine study. Nearly one-third has stopped taking a prescribed drug
  without talking to their health care provider, according to an NPR poll. Further, a review
  in the Annals of Internal Medicine revealed that 20-30% of prescriptions are never filled
  and nearly 50% of chronic disease medications are not taken as prescribed.
- Opioid addiction steals 54,600 American lives every year, and deaths associated with drug overdose, including prescription opioids and illicit drugs, has increased twofold in a decade. In addition to the unnecessary loss of life, opioid misuse is threatening the future of the physicians writing opioid prescriptions.
- Opioids prescription opioids, heroin and synthetic opioids are involved in two of every three drug overdose deaths, underlining the importance of regular prescription drug monitoring.
